Promotional Period for Introductory APR:

Any existing balances on Member One, A Division of Virginia Federal Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Late Payment Fee:

Returned Convenience Check Fee:

\$25.00 or the amount of the returned convenience check, whichever is less.

Card Replacement Fee:

\$10.00.

Document Copy Fee:

\$20.00.

Emergency Card Replacement Fee:

\$250.00.

Rush Fee:

\$20.00.

Statement Copy Fee:

\$5.00.

Stop Payment on Convenience Check Fee:

\$25.00.

Pay-by-Phone Expedited Payment Fee:
