Official Contest Prize Rules

Guns 'N Hoses Ice Hockey Game Event Puck Shot Contest January 25, 2025

1. No purchase is necessary. Entries limited to one per person.
2. Eligibility for Promotion: Participation is limited to U.S. residents. Winners must be at least 18 years of age. Current employees of Member One – A Division of Virginia Federal Credit Union (“Member One”) or Virginia Federal Credit Union and their family members and persons living in the same households of such employees are not eligible to enter. Promotion period begins Saturday, January 25, 2025, at approximately 4:00 pm and ends at approximately 11:00 pm on Saturday, January 25, 2025. To submit an entry, participants will enter their name, address, email address, and phone number on the dedicated contest entry website forum on memberonefcu.com. One randomly-chosen winner will be drawn and notified directly after the drawing. The chosen winner will then be notified of the chance to take a shot on goal for a chance to win up to \$500.00. If the chosen winner is not present, another winner will be drawn for a chance to take a shot on goal for up to \$500.00.
3. Prize: Member One will award \$500 to a present qualified contestant no later than February 28, 2025, in the form of a personal check issued to the contestant by Member One. Potential qualified contestants are able to enter the drawing by signing up at the Member One official table the evening of the Guns 'N Hoses Ice Hockey Game Event on January 25, 2025, at the Berglund Center located at 710 Williamson Rd. NE, Roanoke, VA 24016. Entries: Each contest entry must list a name, address, email address, and phone number. A name will be drawn on January 25, 2025, at the Guns 'N Hoses Ice Hockey Game Event and the chosen winner will then be asked to come down to ice level to participate in the puck shot on goal. By participating in this contest, you agree to be bound by these Official Rules. The winner will be notified by Member One via email or phone call, and may be asked to provide unexpired, government-issued identification for age verification when claiming the prize.
